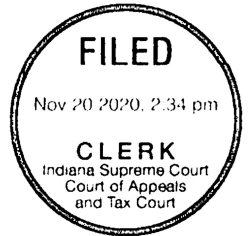

Charles M. Kidd, Acting Executive Director of the Disciplinary Commission of the Indiana Supreme Court, pursuant to Admission and Discipline Rule 23(21), has filed the Commission's Itemized Statement of Expenses allocable in connection with the above-captioned matter.
